- 2. Minutes of previous meetings: It was moved by TPX and resolved that the minutes of the Parish Council meeting held on Monday 20th May 2019 be signed as a true record of the meeting.

- **5. Matters Arising:** TPx advised the meeting that he had received 2 complaints about flowers being left at one of the commemorative trees at the pond. - 7. Report from Planning, BCC & CDC updates:

- ii) Forthcoming consultation on the Chiltern and South Bucks Local Plan and CIL Draft Charging Schedule- JW was asked for his view on the plan and whether there is any impact on the parish. JW gave an overview on the supply of housing required in the District over the next 5 years. JW confirmed that Coleshill parish is still covered under the Green Belt and fully protected.
- **iii)** The work of Fields in Trust- The email received was discussed and it was agreed that David Sharman should be invited to a future meeting.

iv) The Buckinghamshire County Council (Public Footpath No.1 (Part) Parish of Coleshill) Public Path Diversion Order 2019- the previously circulated documents and sealed order were noted. v) Community Infrastructure Levy draft Schedule consultation — JW explained that both Wycombe DC & Aylesbury Vale DC both have their own CIL. Even though Chiltern & South Bucks DC do not have large developments it was felt that any approved application should have a levy that could then go towards services. It was agreed that CPC should support such a levy.

8. Report from Open Spaces:

- i) Monthly Play inspection return The June routine play inspections had been completed. LW reported that the wood around the bark in Hill Meadow play area was rotten and would need repairing. TPx agreed to have a look at what sort of repair was required and report back at the next meeting. LW confirmed the multi-play at Hill Meadow had been repaired.
- **ii) Review of Cricket Club lease-** TPx had completed the annual Cricket Club lease review. Once the CPI figure was available he would send this year's rent figure to the Clerk for invoicing.
- **iii)** Jack Adams Field play area updated quote- Councillors approved unanimously RNC's quote for cutting the Jack Adams Field which would now include a 3metre path from the entrance to the Play trail.
- **iv)** Christmas tree lights quote TPx had rearranged a meeting with Lamps & Tubes to replace the Christmas lights for 18th June. Comparison quotes would be required. Chris Wege **confirmed** he was waiting for agreement from the church committee to complete the work on the tree.
- v) Information from Align- The previously circulated information on `20 is plenty` from Align was noted.
- vi) HS2 CEF application- TPx confirmed he had taken over completing the application from Cllr. Saunders for cutting equipment for the Jack Adams field.
- vii) Hertfordshire House plans- TPx gave an overview of a meeting he had arranged with the manager for Hertfordshire house after receiving a complaint from a parishioner regarding the work on Sampson Hill corner. Mr Cadman had informed TPx of the improvements planned which will make the area look much better. JH agreed that the work being done is improving the area, especially the verges. Mr Cadman advised that a tree could be planted on the site if the village would want it. Mr Cadman has also considered putting benches on the verge as a lot of Duke of Edinburgh participants pass through the area and of course they would also be for residents use as well.

9. Finance:

- i) Cashbook, Bank balances and reconciliation as at 28.05.19— the previously circulated documents were approved.
- **ii)** Annual Finance review—TPx advised the meeting that all had received the report and had the opportunity to review. As there had been no queries raised on the content of the report the information was **approved**.
